IN 2021 FRIENDS OF KAREN FULFILLED THE HOLIDAY WISHES OF 824 CHILDREN, AND DISTRIBUTE BACK-TO-SCHOOL GIFT CARDS AND SUPPLIES TO 625 CHILDREN, AS WELL AS BIRTHDAY GIFTS TO 757 CHILDREN. THE ORGANIZATION PROVIDED THANKSGIVING AND HOLIDAY MEALS AND SUPERMARKET GIFT CARDS AND EMERGENCY FUNDS FOR FOOD YEAR ROUND TO THE NEEDIEST FAMILIES.
